Here's the FFS response so far. The two new item are on the waiver from EDI (separate note to you and Cheri, Meena) and on the SNFs – we're working on suspending the claims edit that would result in rejecting a SNF claim if the corresponding inpatient claim is not found in the system. We don't believe 1812(f) is the appropriate tool here since clinically the stays should still be required.

PCG: HETS transactions with Change Healthcare disconnected as of last week.

MCMG: (1) TDL issued on Friday requiring MACs to report daily on disturbances and requests. Currently, one request in regarding extensions for DME cases from CGS and Noridian a and MCMG coordinating with CPI. (2) Requests regarding waiver from EDI. The MACs administer this process but significant use of this could overwhelm the MACs' ability to process paper claims. So while it's possible to grant waivers on request, it might be preferable to undertake a communications strategy to ensure providers know their options: Wait, Choose to use another vendor or clearinghouse, Submit claims one at a time through the MAC portals, Manually type in claims via CMSnet, Request a waiver from EDI.

CCPG: (1) Hospices requesting extensions on filing Notice of Elections for new hospice elections -- Existing exceptions process exists and hospices would request directly from the MACs. (2) Home health agencies requesting extensions of Notice of Admissions for new HHA admission - Existing exceptions process exists and HHAs would request directly from the MACs. (3) SNFs concerned about claims being rejected because hospital claim for the associated 3 day inpatient stay is not in the system - Intend to send a TDL to suspend the claims edit; working with PBG on timing. (4) Broader requests on waiving timely filing - not yet applicable but will continue to monitor.

P3: Request to exercise enforcement discretion with respect to hospitals that operate internet-based price estimator tools that rely on Change Healthcare for varied functions, including coverage verification – response TBD.

The letter includes our strong statement of support for the Administration's policy that adjusts Part B drug payments and hospital outpatient facility fees informed by survey results on acquisition costs for 340B-acquired drugs since CY 2021. And asserts, due to the recent Supreme Court decision re American Hospital Association v. Becerra, our view that any CMS resolution of the underpayments on drug claims with 340B-participating hospitals, it is unnecessary and would be inappropriate for CMS to adjust payments directly or indirectly on non-drug claims because it discovered, years later, that any assumptions underlying the need for budget neutrality in this case are not accurate.

I wanted to give you a heads up about new national survey results released <u>today</u> that show voters overwhelmingly support CMS' recently proposed reforms to crack down on the abusive overbilling practices of Medicare Advantage insurers â€" which are costing seniors and taxpayers billions.

## Here are a few highlights from the survey:

- Almost nine in 10 voters (87%) favor reforms to reduce Medicare Advantage overpayments. This includes (90%) of Democrats, (85%) of independents, and (86%) of Republicans.
- 70% of voters say the government should do more to **prevent fraudulent billing** practices by health insurance companies in Medicare Advantage.
- 64% say the government should do more to make sure health insurance companies in Medicare Advantage are **not overpaid for the coverage they provide.**

The poll makes it clear that there is support for Medicare Advantage payment <u>reforms</u> which are urgently needed to improve program integrity and hold insurers accountable for providing value to beneficiaries and taxpayers.

Just a heads up that I received the attached from Priscilla Ross at the AHA, who attended one of our events in Chicago earlier this week. The report will be released at 10am today and is titled: Massive Growth in Expenses and Rising Inflation Fuel Continued Financial Challenges for America's Hospitals and Health Systems: Hospitals are experiencing significant increases in expenses for workforce, drugs and medical supplies.

The pandemic has strained hospitals' and health systems' finances. Many hospitals operate on razor thin margins, so even slight increases in expenses can have dramatic negative effects on operating margins, which can jeopardize their ability to care for patients. These expense increases have been more challenging to withstand in light of rising inflation and growth in input prices. In fact, despite modest growth in revenues compared to prepandemic levels, median hospital operating margins were down 3.8% by the end of 2021 compared to pre-pandemic levels, according to Kaufman Hall. Further exacerbating the problem for hospitals are Medicare sequestration cuts and payment increases that are well below increases in costs. For example, an analysis by PINC found that for fiscal year 2022, hospitals received a 2.4% increase in their Medicare inpatient payment rate, while hospital labor rates increased 6.5%.

These levels of increased expenses and declines in operating margins are not sustainable. This report highlights key pressures currently facing hospitals and health systems, including:

- I. Workforce and contract labor expenses
- II. Drug expenses
- III. Medical supply and PPE expenses
- IV. Rising economy-wide inflation
